Subj: **Request for Refund of Tender Advertisement Fee Due to Non-Uploading Tender of Examination Stationery of National University of Pakistan, Islamabad**

1. The Exam Branch, National University of Pakistan, submitted a request on 29th October 2025 for uploading the tender regarding the procurement of Answer Sheets and Stationery Items for Fall-2025 Examinations on the PPRA website (**Annex-A**). In response to the request, PPRA communicated the requirement of an advance payment of Rs. 15,000/- for the Tender/Evaluation advertisement. The required fee was deposited on 30th October 2025, and the payment receipt was forwarded to PPRA on the same day (**Annex-B**).
2. The tender opening date was 18th November 2025; however, the tender did not appear on the PPRA website until 10th November 2025. Upon visiting the PPRA office on 11th November 2025, it was informed that tender uploading was to be carried out through the **E-PAD system**. As the National University of Pakistan functions under the Ministry of Defence and does not possess an E-PAD User ID or Password, guidance was sought from the IT/MIS Section of PPRA. The concerned officer instructed that an official request letter be submitted for manual uploading of the tender through PPRA.
3. Accordingly, a formal request letter was submitted on 13th November 2025 (**Annex-C**). Despite timely submission of all requirements, the tender was not uploaded, resulting in unavoidable delays in the procurement timeline. Due to the sensitive and time-bound nature of examination-related processes, the tender had to be cancelled.
4. In view of the above circumstances, where the tender could not be uploaded despite fulfillment of all prerequisites the refund of the deposited advertisement fee amounting to **Rs. 15,000/-** is requested. The refunded amount may kindly be issued through cheque in favour of **"FEE COLLECTION ACCOUNT OF NATIONAL UNIVERSITY OF PAKISTAN"**

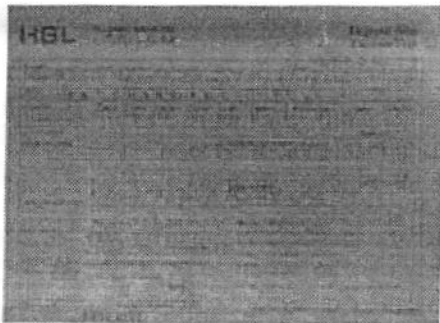

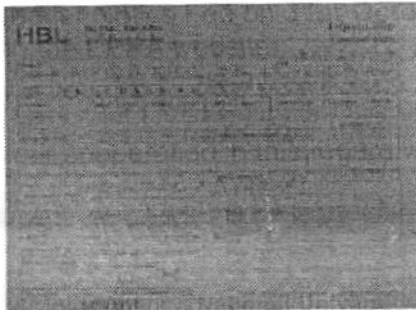
