The tenders must be received in the accepting office by <b>1130 hrs</b> on <b>17 Dec 2025</b> and will be opened at <b>1200 hrs</b> on the same date.						
<b>NOTE:-</b> Contractors shall provide certificate that they are not involved in any type of litigation with Government Department in the Court of Law and that no special report of Directorate of Inspection and Evaluation (E-in-C's Branch GHQ) is outstanding against them.							
12	All contractors will certify in writing that they are registered with Pakistan Engineering Council (PEC) and will submit a copy of their registration. Contractors not registered with PEC are ineligible to apply.						
13	Contractor born on approved list of MES in Category ‘E’ and above and also having experience of this type should only apply.						
14	Contractors who desire may be present at the time of opening of tenders.
