Tenders will only be issued after deposit the tender fee. The tenders must be received in this office by 1130 Hrs on **22 Dec 2025** and will be opened at 1200 Hrs on the same date.

Note:- Contractors shall provide certificate that they are not involved in any type of litigation with Govt Department in the court of Law and that no special report of Directorate of Inspection and Evaluation (E-in-C's Branch GHQ) is outstanding against them.

3. All contractors, will certify in writing that they are registered with Pakistan Engineering Council (PEC), and will submit copy of their registration. Contractors not registered with PEC are ineligible to apply.

4. Contractor borne on approved List of MES in cat 'A' and 'B' and also having experience of this type should only apply.

5. Contractor who desire may be present at the time of opening of tenders.

6. The accepting officer reserves the right to accept or reject the tender. Rejected tender will be dealt with as per Para 33 (i) of PPRA Rules.
