1. Sealed bids are invited from reputable firms for **Hiring of Security Staff at NRTC Business Office Quetta.**
2. **Terms and Conditions**
 - a. NRTC hereby invites sealed bids from well reputed, experienced and license holding Private Security Companies/ firms registered with Income Tax and Sales Tax Department and who are on the Active Taxpayers list of the FBR and Government of Baluchistan.
 - b. Rs 50,000/- earnest money in the shape of Demand Draft / Pay Order in favour of NRTC, Haripur (refundable) must be attached with Technical Proposal. **Tender will be opened on 24th Dec 2025 at 1000 hrs.**
 - c. Affidavit on stamp paper that the Firm / Contractor is not black-listed by any Govt / Authority and is not involved in litigation with any Govt Department / Autonomous Body.
 - d. Contractors are advised in their own interest to visit the NRTC Business office Quetta and ensure provision of Security required to be placed before submitting quotation. It will be deemed understood that the contractor has fully acquainted himself with the detailed nature of work. No claim on account of insufficient knowledge shall be entertained afterward.
 - e. NRTC may reject all the bids at any time prior to the acceptance of bids as per Rule-33 of Public Procurement Rules 2004.
 - f. Single stage two envelop procedure will be followed.
 - g. Firm should mark both proposals separately with the words "**Technical Proposal**" and "**Financial Proposal**", sealed in two separate envelopes, and then seal the two envelopes in a single package.
 - h. Bidders must submit their bids as per tender requirement i.e clearly marked as Financial and Technical proposals. Complete technical literature along with technical bid.
 - i. Evaluation criteria is available with tender.
 - j. Bids can be sent through Post Office/ Courier Services or place in the tender box fixed at NRTC entrance.

Terms and Conditions for Security Company

1. The Security Company shall provide 2x Army Guards at **National Radio & Telecommunication Corporation, FC Sector, HQ north, NRTC Jammer Workshop, Chaman Housing Scheme, Near Askari Park, Quetta.**
 - a. The security Company shall provide security guards comprising of ex-soldiers of Pakistan Armed Forces (Ex Uniformed Guards) to the said party. The security Company will provide medically fit persons who have clean character & having good military bearing.
 - b. The Security Company personnel will obey all instructions of the Employer regarding discipline, and various duties assigned to them within the premises.
 - c. The security company will be responsible for the professional competence of the guards and will replace any guard whose conduct and performance is unsatisfactory.
 - d. All security guards will be medically checked periodically at the expense of the security company and those found unfit will be replaced immediately.
 - e. The Security Company will ensure that no guard over 55 years of age is employed on duty.
 - f. The guards will keep a vigilant watch against any intruder or miscreant within the premises. They will stop any unauthorized person to enter the premises unless otherwise allowed by the NRTC.
 - g. Any untoward incident coming to the notice of the security guards will be intimated to the NRTC. However rules of engagements will be briefed, taken care and responsibility of Security Company.
 - h. The relationship of the Company to the Client shall be that of an independent Company. The company guards provided to the Client pursuant to this Contract shall be the employees of the Security Company and Company shall exercise complete and exclusive control over all aspects of their employment and contract including evaluation and the resolution of complaints and grievances.
 - i. The Primary responsibility of the guard shall be to act as a deterrent to wrongdoings, to provide early detection of safety/ security breaches and to ward off miscreants and unauthorized personnel to the premises. This shall be accomplished by observing and reporting to the Clients. It is expected from the client that it will not force the guard for any act which is not covered under the prevailing law.
 - j. For all operational purposes, The Company guards provided under this Contract shall not be used as Escort / Bodyguard duties or cash Transit, nor shall such guards be deployed at any other premises without prior / written approval from the Company.
 - k. The Client shall not enroll / employ any of the company guards who deserts / leaves any Security Company (for any reason) before six months of his joining to Security Company.
 - l. The Client hereby authorizes the Security company guards provided under this Contract to screen visitors, prevent unauthorized entry / trespass in order to secure and safeguard the property of the Client.

- m. During holidays of the Eids (eid-ul-Fitr & Eid -ul-Adha), the company shall maintain 50% of the strength of guards deployed pursuant to this Contract. Replacement on casual leaves of security guards will be responsibility of Security company.
- n. The security company will ensure that all offices /rooms is properly locked / secured by their own staff at the premises every day.
- o. Either of the party can terminate the signed contract by giving one month's advance notice to other.
- p. The NRTC will not pay any advance or any money to any guard directly.
- q. The Security Company staff will perform duties as per deployment pattern timings as deemed necessary and appropriate by NRTC.
- r. The security Company staff will perform duties on 12 hours shift.
- s. The NRTC will provide the basic humanitarian facilities of accommodation, toilet, Emergency telephone (for firefighting etc) drinking water and shelter from rain / sun for the security guards on duty.
- t. All questions disputes, controversies or claims arising directly or indirectly out of the consequences to this Contract shall be settled by mutual negotiations. Should such negotiation fail, the matter shall be referred to arbitration by two arbitrators, one to be appointed by each party in accordance with and subject to the Pakistan Arbitrator Act, 1940 or any statutory modification or re-enactment thereof. This Contract as a whole or any part thereof may not be altered, modified or amended except in writing and properly executed by both the Parties.

2. The contract will remain in force for a period of one year effective from 01st Jan 2025 and can be extended with the consent of both the parties for further period as may be mutually agreed.
