The bidders shall upload scanned copy of Bid Security on EPADS. Original Bid Security must be submitted to the Procuring Agency on or before the closing date & time of e-bids submission, failing which the e-bid shall be rejected.
4. Samples (if required in the bidding document) must be submitted to the Procuring Agency on or before the closing date & time of e-bids submission, failing which the e-bid shall be rejected.
5. The bidders must quote firm and final prices and no request for escalation in cost after the bid opening shall be entertained.
