

**Instructions to Bidders:-**

1. Bidding documents are available on PPRA E-Pads portal only. No hard issued.
2. Only firms / contractor registered with PPRA E-Pads as vendors are eligible through online E-PADS Tendering. The bidders shall complete and authenticate their complete E-bids (by uploading PDF File) and it must be submitted online on e-Procurement system (EPADS) website i.e. <https://eprocure.gov.pk>.
3. The prospective bidders are required to submit Bid security / Earnest Money (CDR) amounting to as above mentioned against work in favor of Cantt Executive Officer Cantonment Board Sargodha, Club road Sargodha Cantt, CDR must be issued from any schedule bank against firms account. Name of Firm should be clearly mentioned on instrument (Call Deposit / CDR). The prospective bidders shall upload scanned copy of Bid Security on E-PADS and original will be submitted Three (03) days before opening of Bids & pay order is not acceptable.
4. The prospective bidders shall upload scanned copy of certificate is required on Original Judicial Stamp Paper for tender worth of Rs. 1200/- their firm are not involved any litigations.
5. The prospective bidders are also required to submit their Bids online through E-PADS at <http://eprocure.gov.pk> before opening date Original bids in accordance with the provisions of Rule 36 (b) of Public Procurement Rules 2004 and terms & condition defined in the bidding documents.
6. The mode of procurement will be single stage single envelop. Interested bidders are required to submit both Technical and Financial Proposal. Initially only the technical bids will be opened and will be evaluated in accordance with laid down evaluation criteria as well TORs as provided in the bidding documents. Financial bid shall only be opened only of the technically qualified bidder.
7. The Bids will be opened publicity on 24-12-2025 at 2:30 Pm in the presence of Bidders authorized Representatives who choose to attend the opening session to be held at the office of Cantonment Board Sargodha, located at Club Road Sargodha Cantt.
8. In case the total bid amount is less than 10% below the NIT amount, the bidder shall submit call deposit as performance security equal to the difference between NIT amount and total quoted amount less 10% of NIT amount. This call deposit

in addition to the earnest money for the work and shall be deposited at the time of submission of bids.

9. Bids not carrying the performance security shall be rejected. The performance security of the successful bidder shall be released after completion of the project.
10. Participants / firms must submit attested copies of relevant documents with original bid security / CDR's.
11. Quoted rates shall be inclusive of all applicable govt. (federal / provincial taxes).
12. The successful bidder shall be bound to execute an agreement with the procuring agency and all terms & conditions including tender notice shall be binding on hi.
13. Bidder/contractor blacklisted by any government / semi government deptt or involved in litigation or found to be indulged in corrupt and fraudulent practices will be considered non-responsive by the procuring agency.
14. In case of any gazette / occasional holidays the tenders will be opened on the next working day.
15. The Firm providing unsubstantiated under incorrect information are liable to legal action and disqualification from the bidding.
16. The procuring agency reserves the right to reject all bids with assigning a reason there off under PPRA rule 33. The advertisement is also available on PPRA's website.
