Lasbela University of Agriculture, Water and Marine Sciences (LUAWMS), Uthal, District Lasbela, Balochistan, invites sealed tenders through the E-Pak Acquisition & Disposal System (EPADS) from original manufacturers, authorized distributors, and suppliers having valid registration certificates with BST, Income Tax and Sales Tax Departments and appearing on the Active Taxpayers List (ATL) of the Federal Board of Revenue (FBR). The tenders pertain to the supplies of Items and Catering services for the 5<sup>th</sup> Convocation of LUAWMS. Bidders must possess relevant experience and demonstrate sound financial standing. Complete details are available in the Tender Documents.

**General Terms & Conditions:**

1. Tender documents can be downloaded from the EPADS website from the date of publication until **11<sup>th</sup> December 2025**. The tender fee shall be deposited through Bank Draft or Online Transfer in favor of **Own Resources LUAWMS** (A/C No. **PK17NBPA2161003058577877**).
2. The original deposit receipt/Bank Draft as proof of tender fee must be enclosed with the bids.
3. Submission & Opening of Tenders: Sealed tenders must be submitted on or before **11<sup>th</sup> December 2025 at 12:00 PM**. The bids will be opened on the same day at **12:30 PM** in the presence of the University Purchase Committee and bidders.
4. Bidding shall be conducted under the **Single Stage-One Envelope Procedure as per PPRA Rule 36(a)**. All quoted prices must be in Pak Rupees and inclusive of all applicable taxes.
5. Each bid shall comprise one single envelope containing, separately, financial proposal and technical proposal (if any).
6. All bids received shall be opened and evaluated in the manner prescribed in the bidding document.
7. Financial bids must be accompanied by Earnest Money **@ 3%** of the bid amount in the form of Call Deposit issued by any scheduled bank of Pakistan in favor of Director Procurement, LUAWMS Uthal. Bids without the requisite Earnest Money will be rejected.
8. If a bidder withdraws or modifies its bid after submission (including at the time of opening), the Earnest Money will be forfeited. Conditional bids will not be accepted under any circumstances.
9. The successful bidder(s), upon award, shall complete the supply strictly within the stipulated time as per specifications in the tender documents. In case of non-compliance or default, the Earnest Money shall be forfeited in favor of LUAWMS.
10. Bids will be evaluated on the basis of Quality and Cost of the items as specified in the tender documents.
11. LUAWMS reserves the right to accept or reject any or all tenders/bids at any stage as per applicable PPRA Rules.
