 - Manpower : 16 Nos. Highly Skilled persons
 - Duty timings : 08 Hrs/day
- 7) Eight (08) Hours per day, six (06) days a week, with one (01) unpaid weekly rest day.
- 8) Over time will not be applicable/admissible.
- 9) OPD/Emergency facility shall be provided by the Contractor in case of any emergency during duty hours.
