Invitation to Bid

The Overseas Employment Corporation (OEC), Head Office Islamabad, invites sealed proposals from well-reputed Pakistani IT consultancy firms (preferably based in Islamabad/Rawalpindi) for **revamping and enhancing OEC's existing online Job Portal and developing an integrated HR talent pool platform**. Bidders must be registered with relevant tax authorities in Pakistan (Active NTN and GST registrants) and possess demonstrated experience in similar projects. The procurement shall be conducted in accordance with **Single Stage – One Envelope** bidding procedure under **Rule 36(a)** of the Public Procurement Rules, 2004.

General Terms & Conditions:

- i. The detailed Request for Proposals (RFP), containing Terms of Reference, scope of services, evaluation criteria, and prescribed forms, is available on the PPRA e-procurement portal (E-PADS Portal (<https://eprocure.gov.pk>) and OEC's website. All prospective bidders are advised to carefully read the complete tender document prior to preparation of their bids
- ii. A non-refundable tender fee of **PKR 3,000** is required, to be deposited in **OEC's account No. PK26 HABB 0001127927495901 (Account Title: O.E.C Corp. Pvt) at HBL Aabpara Branch, Islamabad**. Proof of fee payment (deposit slip) must be attached with the bid.
- iii. A **mandatory pre-bid meeting** will be held on **Friday, 05th December 2025 at 4:00 PM** in the **Conference Room of OEC Head Office (6th Floor, EOBI House, G-10/4, Islamabad)**. All interested bidders must attend this meeting to seek clarifications and visit the existing system. Failure to attend the pre-bid meeting shall result in disqualification from the bidding process. (OEC's record of attendance will be used to confirm this criterion).
- iv. Participating firms **should have relevant experience** in IT systems development, with **proven execution of similar projects** (job portals or large-scale web applications, nationally or internationally) in the last five years.
- v. The bidders must not be blacklisted by any Government or public sector organization (an affidavit to this effect is required).
- vi. Each bid must be accompanied by a **Bid Security (Earnest Money)** as mentioned in RFP document in the form of a Pay Order or Demand Draft from a scheduled bank in favor of **Overseas Employment Corporation**. *Scanned proof of the bid security* should be uploaded with the e-bid, and the original instrument must be delivered to OEC **before bid opening time**. **Bids without required bid security will be rejected.**
- vii. All applicable taxes will be deducted as per Government of Pakistan regulations.
- viii. Bids must be submitted electronically via EPADS on or before **15th December 2025, by 03:00 PM**. Manual submissions will not be accepted. **The bids will be opened electronically** on the same day at **11:30 AM**, in the presence of bidders or their authorized representatives at the **Conference Room of OEC Head Office, situated on 6th Floor, EOBI House, G-10/4, Islamabad**.
- ix. OEC reserves the right to **accept or reject any or all bids** as per PPRA Rule 33, and to annul the bidding process at any time prior to award without thereby incurring any liability.
- x. Conditional or incomplete bids shall be considered non-responsive and will not be entertained.
