5. In case, if the bids are not opened on the scheduled date, due to force majeure / unavoidable circumstances the same will be opened on the next working date in the presence of committee and bidders. The bids will be received from the bidders signed by the receiving members in sealed condition.
6. All applicable Government taxes i.e. GST, Income Tax etc. will be required to be paid by the successful bidder at **prevalent rates / 18% GST & 10% withholding tax and to be incorporated in the bid.**
7. All offers / bids shall be valid for **180 days**. Unsuccessful bidder's pay order will be returned after conclusion/finalization of the proceedings.
8. Conditional bids / offers shall not be entertained.
9. The bidder must satisfy themselves on all the points before bidding, after that no objection/query will be accepted.
10. Bidder must attach Copy of their CNIC and contact Number along with bids.
11. The successful bidder will have to pay the full and final cost of the vehicle as approved by PQA in the shape of pay order in favour of Port Qasim Authority within fifteen (15) days of issuing of acceptance letter in case of default acceptance letter will deem to be withdrawn and Bid Security will be forfeited.

The auctioned vehicles will lie on the spot, entirely at the risk of successful bidders / authorized persons and they must be removed/cleared within fifteen (15) days, after receipt of full payment. Final delivery order and gate passes for the release of auctioned vehicles will be issued by PQA, auctioned vehicles be released on production of receipt showing full payment of bid money and delivery order issued by PQA. Successful bidders / authorized person will arrange necessary equipment / labour at their own for lifting of the vehicle(s) from PQA.
13. In case in any document / financial instrument is found forged, the Bid Security of the bidder will be forfeited.
14. All expenses i.e. transfer / re-registration etc. will be borne by the bidders.
15. PQA reserves the right to reject the highest or any other bid or cancel/withdraw any item(s) from the auction without assigning any reason whatsoever.
