Bidding is open to all eligible bidders ie. contractors duly licensed and renewed for year 2025-26 or renewed for year 2024-25 with deposit slip for year 2025-26 by the Pakistan Engineering Council (PEC) as mentioned in bidding documents. The bids are being invited on "Single Stage One Envelope" tendering procedure as per PPRA rules on percentage above/below basis. A criterion for evaluation is provided in the bidding documents. A complete set of bidding documents for each work is available at E-PADS Portal ([www.eprocure.gov.pk](http://www.eprocure.gov.pk)) and can be downloaded till **11.00 AM on 22.12.2025**.

Bid security (in original), in an acceptable form as mentioned in the bidding documents, in favor of 'Chief Executive Officer LESCO, LESCO Headquarters Lahore must be delivered to this office till **11.00 AM on 22.12.2025** physically and a scanned copy of the same must be uploaded on E-PADS. Bids will be opened at **11:30 AM on 22.12.2025** through EPADS.

1. Single Stage One Envelope' tendering procedure with "Least Cost Method" will be adopted.
2. After evaluation of the bids, the Employer will publish evaluation report on the E-PADS portal, which shall be accessible to all registered bidders
3. This tender is floated on percentage above/below basis
4. Bidding documents available on PPRA E-PADS ([www.eprocure.gov.pk](http://www.eprocure.gov.pk)) can be downloaded and used for bidding purpose for each work bid security to the same office.
5. Tenders can also be seen from LESCO Website [www.lesco.gov.pk](http://www.lesco.gov.pk) for reading purpose only.
6. Original CDR/Pay Order as bid security of amount mentioned in bidding documents is necessary to be attached with the tender / bidding documents for each work and scanned copy of the same must be uploaded on E-PADS otherwise tender will not be entertained.
7. Only eligible contractors duly licensed and renewed by the Pakistan Engineering Council (PEC) for FY 2025-26 or renewed for FY 2024-25 with deposit slip for FY 2025-26 as mentioned in bidding documents can participate
8. 5% performance security as per letter of acceptance will be deposited by successful bidder within 14 days in shape of bank guarantee/pay order/CDR otherwise his deposited CDR will be forfeited and work will be awarded to next lowest bidder. **Insurance guarantee will not be accepted as performance guarantee.**
