


NOTICE INVITING TENDERS

Title of Procurement	Procurement of Transportation Services on "aggregate Rs. /MT charge basis" for disposal of Fly Ash, Bottom Ash and FGD Gypsum and dumping in compliance with SEPA guidelines on designated sites/facilities "as & when produced" as a result of burning 100% Imported Sub-bituminous Coal and blend of Imported Sub-bituminous Coal with Thar Lignite in a ratio of 80:20. The bidders who are capable for disposal of Fly Ash in specialized Bulkers and Bottom Ash/FGD Gypsum in Dumpers/Trucks properly covered with tarpaulin in compliance with SEPA guidelines, are invited to submit sealed bids for Disposal of Fly Ash, Bottom Ash and Gypsum on unit rate "Rs/Metric Tons" , 24/7 round the clock maintaining the Silos' levels <u>free</u> at 75% all the times, from 660MW CFPP Jamshoro, a Government Owned Entity, under Ministry of Energy (Power Division) Islamabad.

(b) Registered & renewed by FBR for FY 2025-26 and are on active taxpayer list for Income Tax & SRB (c) Have no conflict of interest and is not blacklisted or debarred by any Govt/Private organization (d) Satisfy key eligibility and qualification criteria as set out in Tender Document
