5. A bank draft or pay order for Rs. 1,200,000/- in favor of "Pakistan Airports Authority" as earnest money must accompany the tender documents. Tenders without earnest money will not be considered.

The bidder must have completed at least one work of worth Rs. 60 million related to runways, taxiways, airport buildings, or airport infrastructure during the last three (03) years, duly supported by valid completion certificate(s). Average annual turnover of minimum Rs. 100 million for the last three years duly supported by audited financial statements for the last three years.
7. The original bid security and one sealed hard copy of bidding documents uploaded on EPADS must be submitted to the office of the Divisional Engineer ES Civil Airside IIAP, Islamabad before the bid closing date and time along with the following documents:
  - a. Proof of payment of the non-refundable tender fee of Rs. 2,000/- in favor of the Pakistan Airports Authority (PAA), to be deposited in the PAA Collection Account (Account No. 24807000037803, HBL IIAP Islamabad Branch).
  - b. Copy of the valid PEC license

  - d. Power of attorney on non-judicial stamp paper with a minimum value of Rs. 500/- (if applicable)
  - e. Affidavit of proprietorship, duly attested, on non-judicial stamp paper with a minimum value of Rs. 200/- (if applicable)
  - f. Copy of valid income tax/active taxpayer status and professional tax registration
