


MEPCO TENDER NOTICE

1. Bids are invited from firms duly approved and registered with the Pakistan Engineering Council (PEC), renewed for the year 2025-26, having specialization codes EE-04, EE-06, and CE-10, for the works listed below. Only electronic bids submitted through EPADS will be accepted. The last date for submission is 18-12-2025 at 12:30 PM. Manual bids shall not be entertained. Bids will be opened the same day at 02:30 PM under the single-stage single-envelope procedure, in the presence of the Bid Opening Committee and those bidders who choose to attend at the designated venue.
2. Bidding documents, containing detailed terms and conditions, are available online and can be downloaded free of cost from the PPRA EPADS website (www.eprocure.gov.pk).
3. An original Bid Security of 5% of the quoted amount, in the form of a CDR (without validity limit), must be deposited in the office of the AM (Accounts), Project Director Construction MEPCO, HQ Khanewal Road, Multan, before the bid submission deadline (12:30 PM) with separate application on company letter pad for each tender. Bids without bid security shall not be considered.
