TERMS & CONDITIONS

1. Electronic Bid must be submitted on EPAD on or before **15.12.2025 at 11:00 AM** which will be opened on the same day at **11:30 AM** in the presence of tenderes or their representatives who desire to participate.
2. Bid Money of Rs. **200,000/-** in the form of pay order/demand draft made in the name of Pakistan Mineral Development Corporation (PMDC) on account of bidder from any scheduled bank shall accompany the bid/tender. Tender with less or without bid money (in the form of pay order/demand draft) or pay order/demand draft without the name of bidder shall not be considered.
3. Tender should remain valid for 90 days period from the date of opening of tender.
4. Tender with over-writing, cutting or conditional or optional or by fax shall not be accepted. Unsigned tenders shall not be considered.



5. The successful contractor will sign contract agreement on the approved pattern for development/drivage excavation with the PMDC within 10 days of the receipt of acceptance letter.
6. The successful contractor will deposit security money equal to 10% of one year development target on excavation with PMDC which will be refunded to him on successful completion of the contract. However, the contractor will not be entitled for any profit/interest on this security deposit.
7. The period of contract will be one year w.e.f date of issuance of work order.
8. The excavation contractor will have to work as per the layout provided by Project Management which may alter during the course of development as assessed by surveyors under the direction of Project Manager failing which the contract will be terminated.
9. The contractor shall be responsible for all liabilities under Act, rules, regulations and notification concerning motor vehicle, EOBI cost of living allowance, Minimum Wages.
10. Education cases, Workmen compensation and any benefits allowed by the Federal/Provincial govt. from time to time.
11. The contractor will be bound to remove the excavated material and clean the working faces.
12. Explosive required by excavation contractor will be provided by PMDC Salt Mines, Khewra from its authorized magazine in such quantity as may be necessary at actual cost plus handling charges @ 10% and total cost will be recovered from the bill of the excavation contractor.
13. In case the contractor fails to drivage the tunnel as per the assigned target length, penalty shall be charged @ 50% of cft excavation rate on quarterly basis.

TERMS & CONDITIONS

1. Electronic Bid must be submitted on EPAD on or before **15.12.2025 at 11:00 AM** which will be opened on the same day at **11:30 AM** in the presence of tenderes or their representatives who desire to participate.
2. Bid Money of Rs. **200,000/-** in the form of pay order/demand draft made in the name of Pakistan Mineral Development Corporation (PMDC) on account of bidder from any scheduled bank shall accompany the bid/tender. Tender with less or without bid money (in the form of pay order/demand draft) or pay order/demand draft without the name of bidder shall not be considered.
3. Tender should remain valid for 90 days period from the date of opening of tender.
4. Tender with over-writing, cutting or conditional or optional or by fax shall not be accepted. Unsigned tenders shall not be considered.



5. The successful contractor will sign contract agreement on the approved pattern for development/drivage excavation with the PMDC within 10 days of the receipt of acceptance letter.
6. The successful contractor will deposit security money equal to 10% of one year development target on excavation with PMDC which will be refunded to him on successful completion of the contract. However, the contractor will not be entitled for any profit/interest on this security deposit.
7. The period of contract will be one year w.e.f date of issuance of work order.
8. The excavation contractor will have to work as per the layout provided by Project Management which may alter during the course of development as assessed by surveyors under the direction of Project Manager failing which the contract will be terminated.
9. The contractor shall be responsible for all liabilities under Act, rules, regulations and notification concerning motor vehicle, EOBI cost of living allowance, Minimum Wages.
10. Education cases, Workmen compensation and any benefits allowed by the Federal/Provincial govt. from time to time.
11. The contractor will be bound to remove the excavated material and clean the working faces.
12. Explosive required by excavation contractor will be provided by PMDC Salt Mines, Khewra from its authorized magazine in such quantity as may be necessary at actual cost plus handling charges @ 10% and total cost will be recovered from the bill of the excavation contractor.
13. In case the contractor fails to drivage the tunnel as per the assigned target length, penalty shall be charged @ 50% of cft excavation rate on quarterly basis.
14. In case the contractor fails to fulfill contractual obligations of his contract. The contract shall be cancelled and security money will be forfeited and the work will be assigned to some other party/firm on the risk and cost of contractor.
15. The contractor will have to under-take all related works such as drivage of tunnel, maintenance of tunnel, maintenance of tunnel mouth, pumping of water from the Mine and electrification of Mines etc.
16. Any unworkable rate appears to have been quoted for dislocation of work will not be considered.
17. The Contractor will follow all the rules & regulations under labour law, payment of wages act, treatment in case of accident or injury during work, recovery made on account of EOBI on actual basis will be deducted from the excavation bills of the contractors. Deduction @ Rs.5/- per cft as insurance fund will be deducted from the excavation bills of the contractor.



18. Before commencement of work, the contractor will have to arrange medical check-up of the labour on a prescribed form and submit medical fitness certificate of each worker along-with copies of CNIC.

19. The contractor shall be bound to carry out work strictly in accordance with the provisions of Mines Act, 1923 and other relevant Rules/Regulations. The contractor shall be responsible to take due care in respect of the person to be engaged and he will provide safety helmets etc. to the labourers to be engaged by him.

20. All Govt. taxes will be applicable i.e. GST (PRA), Income Tax etc. The rate quoted should be inclusive of all taxes.

21. Contractor/firm should have minimum 05 years' experience of relevant work & have to submit experience certificate (copy of work orders) to this effect.

22. Contractor/firm should be registered with local tax authorities and be incorporated under Pakistani law evidence should be attached with bids.

23. Contractor/firm must be of sound financial health and shall provide certified bank statement covering last 12 months (from the date of submission of bid).

24. Contractor/firm must provide a list of names of all of its owners, directors and management team alongwith their brief resumes.

25. Contractor/firm or any its subsidiary companies or any of its directors/owners or any of their relatives (parents, children, brother, sister) should not be under litigation with PMDC in any local or foreign court of law.

26. Contractor/firm or any its subsidiary companies or any of its directors/owners or their relatives (parents, children, brother, sister) should not have any ongoing, unresolved business dispute with PMDC. PMDC shall be the sole judge of fulfillment of this requirement.

27. In case any dispute including shortening or excess of size/drivage, breach of official decorum, misleading statement and non-compliance of written instructions, the matter will be referred to the competent authority. In case the matter is not resolved, the MD, PMDC will be sole Arbitrator and his decision will be final and binding on both the parties as per provision of Arbitration of Act, 1940.

28. I agree to the above terms and conditions and give my acceptance.

29. The following documents should be attached with tender document as the time of opening, otherwise the tender will not be entertained/considered.

30. The finished size of tunnel will be length x height (7' x 7') where required the same will be more than 7' x 7' for the purpose of supports or lining.



31. The contractor will have to drive at least 34ft per month.
32. Total length of the Tunnel will be about 400ft and will be at the grade as per layout as provided/directed by Project Manager.
33. The waste material from drivage in soil and debris will be disposed off at proper site to be indicated by Project Management.
34. Explosive will be issued from PMDC Magazine the price of explosive will be deducted from running bill.
35. The contractor is required to complete the job within a year from the issue of work order.
36. Lifting of excavated waste material will be solely responsibility of the contractor and he will make sure clearing the face on daily basis.
37. Any additional safety measures will be provided by contractor, as per PMDC HSE manual/ bid tender documents.
38. In case of medical, fatal accident the contractor will be responsible to pay under workmen compensation Act./under Mines laws/ Act/ rules/ compensation Act.
39. Rate will be offered on CFT basis.
40. Preparation of proper working face to the satisfaction of technical team before drivage will be responsibility of the contractor.
41. Alignment, grade shape and size of tunnel will be of prime importance and the contractor will follow the directions of technical team of the Project.
42. Penalty on short drivage (cfts) will be imposed @ 50 % of offered cft rate.
43. Proper ventilation system through blower fans etc. for dilution of contaminated air will be installed by the contractor.
44. In case of water in-inundation, pumping will be responsibility of the contractor.
45. Electricity if required will be allowed to the contractor on recoverable basis, for which all installations, operations, safety measures will be the sole responsibility of the contractor for which contractor will follow the HSE manual of electrification.
46. All the machinery, equipment's, PPE, will be arranged by contractor at its own and will have to follow international HSE standers, wherever fitness certificate will have to be provided prior to the start of operations, alongwith monthly at required interval fitness checkup afterwards.
47. Manhole/ escape space shell be excavated at a distance of each 100 foot from center to center or where required and instructed by Project Manager.
