The Employer, Pakistan Water and Power Development Authority (WAPDA), through the Project Director, Mangla Watershed Management Project (MWMP), Islamabad, invites electronic bids via the e-Pak Acquisition & Disposal System (E-PADS) from eligible firms/contractors for execution of Engineering Works & Afforestation Works under FY 2025-26. Bidding shall be conducted under the Single Stage – Single Envelope Procedure as per WAPDA/PPRA rules.

- Registration with FBR/GoAJK and inclusion in ATL.
- Experience of similar nature works completed in the last five years, with completion certificates.
- Adequate financial soundness, supported by Cash Flow / Bank Statement.

#### 3. Tender Documents

Only registered bidders may participate.

#### 4. Bid Submission & Opening

- Bids must be submitted electronically through E-PADS up to 1100 hours on **16.12.2025**.

- Manual bids are not accepted.

- Electronic bids will be opened on the same day at 1130 hours, Committee Room, WAPDA Administrative Staff College, 4 Piras Bukhari Road, Sector H-8/1, Islamabad, in presence of authorized representatives.

#### 5. Terms and Conditions

- Submission of false/forged documents will result in bid security forfeiture and may lead to blacklisting under WAPDA/PPRA rules.
- Bid Security shall be submitted only in the form of a CDR in favor of Project Director, Mangla Watershed Management Project, WAPDA, Islamabad.
- Firm's name must appear on the CDR.
- Scanned copy to be uploaded with the bid; original CDR must reach the undersigned by 1100 hours on bid opening day; otherwise bid security will not be accepted.
- Signed & stamped Form of Bid, BOQ, and Contract Data must be uploaded; non-compliance leads to rejection.
- Successful bidder shall submit a 10% Performance Guarantee (Pay Order/CDR + Insurance Bond from AA-rated insurer) before contract signing.
- All Federal, Provincial, and AJK taxes shall be borne by the bidder.
- Employers may accept or reject any/all bids as per PPRA Rule 33(1).
