1. The Employer, Pakistan WAPDA represented by Resident Engineer (Civil) MDO Mangla, invites electronic bids from eligible firms licensed by the Pakistan Engineering Council in category C-6 or above having specialized code in the relevant field renewed for year 2025-26, registered on Active Tax Payer list of FBR / FBR GoAJK:

2. E-bidding documents as per regulations, containing detailed terms and conditions, specifications and requirements etc. for the work are available for the registered bidders on EPADS at (www.eprocure.gov.pk)

3. The electronic bids must be submitted by using EPADS on or before 11:30 hours on 11.12.2025. Manual bids, shall not be accepted. Electronic Bids will be opened on the same day at 12:00 hours at Committee Room of Project Office, Mangla Dam Organization (MDO), WAPDA Mangla.

Terms & conditions:-

a) Application on original letter pad must contain complete address, contact number (PTCL).

b) The bid security shall be submitted only in the shape of CDR in favour of Resident Engineer, (Civil) MDO Mangla (The name of firm must be mentioned on the CDR). The copy of CDR shall be uploaded with **electronic bids and original CDR must be submitted to the undersigned on date of bid opening but not later than 11:30 hours, otherwise bid security will not be accepted.**

c) The bidders should upload signed & stamped form of bid/BOQ/contract data; otherwise the same will be rejected.

d) The quoted rates must be inclusive of all applicable government (Federal/AJK) taxes and no rates should be quoted which are exclusive of any tax.

e) Discount/Rebate must be mentioned clearly on respective Bill of Quantities in terms of Percentage (%) or Lump-Sum amount.

f) Presentation of false/wrong documents will be strictly discouraged and their Bid Security shall be forfeited besides black listing.

g) The Bidder shall upload PEC registration certificate and details of Active tax payer.

h) WAPDA reserves the right to accept or reject any or all tenders as per PPRA Rules.
