- Bids will be opened and downloaded from **EPADS** on the opening date and time as given above. Proposals of technical qualified bidders will be announced on EPADS system accordingly and will be accepted after completion of all codal formalities.
- Estimated Cost is of this procurement is Rs. 1,250,000/-.
- Bid Security amount including tax, of **Rs. 62,500/-**, in the shape of CDR/Pay order favoring **“State Life Insurance Corporation of Pakistan”** must be submitted by bidders at the address given in tender notice/documents before closing time, else bid will be rejected. In case a vendor submits a bid lot-wise, the bidder shall provide a CDR equivalent to 5% of the total quoted amount for that particular lot.
- The Bid Security will be returned to un-successful bidders after completion of formal procedure and to successful bidder after completion of work. However, successful bidder will be required to submit performance guarantee of 10% (value of Job Order) in shape of bank guarantee (valid for at least 01 year) in favor of State Life Insurance Corporation of Pakistan which shall be released **after expiry of one year after completion of warranty period**.

Terms & Conditions:

1. Only Income tax and Sales Tax registered (active tax payers) vendors/General Order suppliers can participate in the tender through EPADS. Provide documentary evidence related tax registrations.
2. Bidders are required to upload their bids on EPADS system as per laid down PPRA procedure for **“Single Stage Single Envelope Method”** and clearly marked as **“Tender No. 02/SKP/S.H/Capital Items/2025”**.
3. Bids can be submitted/uploaded at EPADS till closing time **10:30 AM** on **12-12-2025**. Submitted bids shall be opened at **11:00 AM** on same day i.e **12-12-2025**.
4. Bids will be downloaded and opened from EPADS on the opening date and time as given above. Proposals of technical qualified and most advantageous bidders will be announced on EPADS system accordingly and will be accepted after completion of all codal formalities.

5. In case wherein on bid opening day, holiday announced by prevailing Government or Zonal Office could not operate due to unavoidable reasons, then bid opening meeting shall be held on very next working day.
6. Estimated Cost is of this procurement is Rs. 1,250,000/-.
7. Bid Security amount (Earnest money) including tax, of **Rs.62,500/-** in the shape of CDR/Pay order favoring **“State Life Insurance Corporation of Pakistan”** must be submitted by bidders at the address given in tender notice/documents before closing time, else bid will be rejected. In case a vendor submits a bid lot-wise, the bidder shall provide a CDR equivalent to 5% of the total quoted amount for that particular lot.
8. The Bid Security will be returned to un-successful bidders after completion of formal procedure and to successful bidder immediately after completion of work. However, successful bidder will be required to submit performance guarantee of 05% (value of Job Order) in shape of bank guarantee (valid for at least One Year) in favor of State Life Insurance Corporation of Pakistan which shall be released after expiry of one year after completion of job.
09. Evaluation of bidders shall be made in the light of **SINGLE STATE, SINGLE ENVELOPE PROCEDURE** as per PPRA Rules 2004.
10. Approximate time of procurement process is 45 days. Order shall be placed to successful bidder after completion of all codal formalities. Approximate payment time shall be 2 weeks after successful delivery/installation as per tender requirements.
11. Each Tender item (Lot Sr. 1 to Lot Sr. 3) shall be evaluated separately. However, Lot Sr. no 1 (One Job) is complete set of jobs and Lot Sr. no 02 (One job) is also complete set of jobs. No bidder shall be allowed to exclude or skip any item from each set. A bidder interested to quote for Lot Sr. 01 or 02, he must quote for complete set. If any bidder does not quote/exclude any item from Lot Sr. # 01 or 02, he shall be technically disqualified for entire item serial of related set. In any Lot item serial, complete participation is compulsory. Overall lowest bidder for complete Lot set if found technically qualified shall be successful for that Lot.
12. Successful bidder will have to start supply within 3 days after confirmed work order and must complete the supply in all respects within 15 working days; otherwise, retention money (CDR) will be forfeited. In addition to this liquidity damages as penalty may be imposed after expiry of 18 working days in case of incomplete task, at 1 % per day of the total work order value.
13. Warranty of items must be accordingly as mentioned in Annex-2 for any type of defect, with free repair/replacement of item/parts within warranty period.
14. Quote only **single rate for each Lot**, which must be irrevocable, unconditional & inclusive of all taxes & expenses (if any).
14. Validity of the rates/bid must be at least 90 days from the date of opening of bid, which may be extendable with mutual consent.
15. Competent Authority reserves the right to reject/cancel/withdraw any/all bid(s) or proposals at any time before award of contract without assigning any reason thereof.

16. Quantity mentioned against items may be increase/decrease by competent authority before placement of order.

17. Eligibility criteria mentioned below must be observed and fulfilled. An Affidavit of Rs. 100 (non judicial stamp paper) in this regard must be attached with the bid.

Technical Evaluation Criteria (Annexure-1)

Technical bids shall be evaluated on the basis of following points:-

A bid having lower of specifications or lower of required brand's specifications then it shall be rejected technically.
- 2** Warranty must be according to requirements of tender documents.
- 3** Satisfactory reports or work orders from the previous reputed clients (at least 2) of the quoted item must be provided with bid.
- 4** Bidder has provided NTN & GST Registration Certificate, having active taxpayer status in FBR.
- 5** Bidder has provided affidavit of Rs. 100/- (Non-blacklisted etc) in the light of Para 17 of Terms & Conditions of Tender Documents.
- 6** All points of Technical Evaluation Criteria, Terms & Conditions are compulsory. Failing in any point/criteria, may result in rejection of the bidder technically.
