3. The electronic bids must be submitted by using EPADS on or before **11:30 Hrs.** on dated 16.12.2025. Manual bids, shall not be accepted. Electronic Bids will be opened on the same day / date at **1200 Hrs.** in the o/o Resident Engineer Hydel Power Station Shadiwal (Gujrat).

TERMS & CONDITIONS

A) Application on original letter pad must contain complete address, contact number (PTCL/Cell).

B) Bid Security shall be submitted only in the shape of CDR in favor of Resident Engineer Hydel Power Station Shadiwal. The name of the firm must be mentioned on the CDR. The CDR shall be uploaded with Electronic Bids and original CDR must be submitted to the undersigned on the date of bid opening but not later than 11:30 hours, otherwise bid security will not be accepted.

C) The Bidders should upload signed and stamped form of Bid/BOQ/Contract Data, otherwise the same will be rejected.

D) The quoted rates must be inclusive of all applicable government taxes and no rates should be quoted which are exclusive of any tax.

E) Presentation of false/wrong documents will be strictly discouraged and their Bid Security shall be forfeited besides black listing.

F) The Bidder shall upload their certificates and details of Active Tax Payer.

G) WAPDA reserves the rights to accept/reject the bids under the provision of PPRA Rule.
