

2. Tender bids would be collected and opened as per following schedule:-
 - i. Firms/ Companies registered with Federal Board of Revenue (FBR) with respect to Income Tax, Sales Tax and are enlisted as Active Tax Payer with FBR for current financial year 2025-2026 and have at least 3 years experience in operating/ functioning of canteen/ cafeteria in the Government/ Semi Government department or reputed institute/ organization are eligible for participating in bidding process.
 - ii. Tender documents may be obtained upon payment of Rs. 1,000/- (One thousand only) non-refundable from the office of Cashier, Islamabad Model College for Girls, F-6/2, Islamabad OR can be downloaded free of cost from EPADS website (<https://eprocure.gov.pk/>) from 14th November, 2025 to ~~30th November~~ ^{02-December}, 2025 till 10:00am
 - iii. Bidders must have satisfactory reports/ performance certificates earned from their previous clients and have relevant necessary license & certifications issued by relevant department.
 - iv. Tender bids will be opened in the office of the undersigned in the presence of firm's representatives as on 30th November, 2025 at 10:30am.


4. Bidders are required to offer competitive prices by including all type of taxes/ General Sales Tax (GST) etc.
5. The bidders will submit financial stability certificate from their bankers and should attach at least previous two years bank statement.
6. If for any reason the office remains closed on the date of opening of tender, the tender will be opened on the next working day at the same time and place.
7. Conditional/incomplete tenders will be liable for rejection.
8. Firms not fulfilling the requirements of PPRA rules will not be entertained.
9. The tender will be finalized through EPADS.
10. Affidavit that the firm is not black listed form any Government or Semi Government department may be given with tender documents.



TENDER TERMS & CONDITIONS**

1. Sealed tenders are to be submitted by Income Tax and Sales Tax Registered firms/ companies.
2. The bidders must quote and provide their CNIC, NTN, GST with the Federal Board of Revenue, certificate as Active Tax Payers member of FBR for current financial year 2025-2026 on current date, must also be provided with the bid/ quotation failing which their offer will be rejected.
3. Conditional, incomplete, without signature, and over writing in bids without initials, will not be accepted, Use of ink remover/whitener is prohibited.
4. Telephonic/ telexed/faxed/telegraphic/emailed bids/offers/quotations will not entertained.
5. The bidders should quote the price(s) according to the specifications/ quantities as mentioned in the bidding document, other than specification the rates will straightaway be rejected.
6. Number of items mentioned in the tender document may be increased or decreased, as per PPRA Rules, depending on the merits and circumstances. Institution has right to cancel any item, whole bid or all bids before signing contract/ Issuance of work order/ award of contract etc in accordance with the PPRA Rules.
7. Firm must not be blacklisted by any Govt. or public sector organization and should not be involved in proceedings in any legal or arbitration court.
8. The sealed bids/ offers may be submitted in the office of Admin Officer/ Member purchase committee at Islamabad Model College for Girls, F-6/2, St. No. 25, Islamabad on or before 22 December, 2025 till 10:00am.
9. The bids will be opened on the same date in the presence of the bidders or their representatives who wish to present.
10. All bids submitted after the time prescribed shall be rejected and returned without being opened as per clause-28 of Public Procurement Rules, 2004.
11. Any bid submitted without earnest money @ Rs. 100,000/- (One hundred thousand only) in form of Demand Draft/ Pay Order/ CDR, will be rejected.
12. The bidders are required to offer competitive prices by including all type of taxes/General Sales Tax (GST) etc.
13. Affidavit that the firm is not black listed from any Government or Semi Government department may be given with tender documents.
14. The price offered should be for the complete quantity as mentioned in bidding documents; partial quantity offers shall straightaway be rejected. Conditional/Optional offers will also be rejected.

15. Bidders will clearly state the minimum number of staff members to be engaged such as cook, seller, cleaner etc. As this is a female institution contractor must have to engage atleast two female staff for purpose of sale/service at canteen.
16. Whatsoever circumstances, the contracted prices of all items will remain firm/ valid up to expiry of contract period i.e. initially for one year and may be extended up to one year more upon satisfactory services.
17. The earnest money will be refunded to all unsuccessful bidders, after the award of canteen contract (agreement). Whereas the earnest money of successful bidder will be included in the amount of security deposit.
18. This College Canteen/ Cafeteria's per month rent will be Rs. 65,000/- (Sixty thousand only).
19. Electricity charges will be claimed as per units consumed by the contractor shown on sub-meter.
20. Gas connection/ supply will not be provided by the institution in college canteen/cafeteria. Contractor will arrange gas cylinder himself.
21. The security deposit will be Rs.250,000/- (equal to three months and 55,000 as security deposit for utility bill (Electricity bill)).
22. No rent will be charged during summer vacations, during the Holy month of Ramadan the canteen committee will decide.
23. The successful bidder will submit samples before commencing/ award of contract that will be examined by the inspection committee nominated by the Principal.

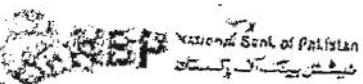
