Accordingly, a Project Planning and Development Unit (PPDU) has been established in the Ministry for monitoring of ongoing projects and identification of viable prioritized projects/new investment initiatives. PPDU, MoWR now seeks the services of Individual Consultant (herein after termed the “Consultant”) that can provide technical assistance to ascertain/assess the impact of activities taken under original projects/loans as well as activities completed.
