2. FESCO invites E-Bids from the Contractor registered with **Pakistan Engineering Council** and renewed for the year **2025-26** along with upto date registration active **PRA**, on **percentage basis (Above / below) on estimated amount / Tender Total Bid Amount (Unit Rate Based)**, under Single Stage-Single Envelope bidding procedure, from eligible firms under **National Competitive Bidding (NCB)** basis in accordance with Provisions of PPRA Rules 2004 amended upto date.

ELIGIBILITY

3. The Bidder meets the following requirements will be eligible for participation in the Bidding (**Through E-PADS**): -
 - a. Pakistan Engineering Council Certificate renewed for the **year 2025-26** with Category having Specialization Code as mentioned against above.
 - b. **The bidder shall be in the active tax payer list (ATL), and will provide** income Tax Returns for last financial year.
 - c. The contractors are required to submit their registration for sales tax with Punjab Revenue Authority (**PRA**).
 - d. Identity Card of Contractor / Managing Partner / Director of the firm.
 - e. The bidder must have completed at least two contracts of same nature along-with its completion successfully as main contractor within Ten years awarded by **WAPDA / NTDC / DISCOs**. The consolidated value of these contracts **must be atleast equal to the estimated / B.O.Q (Cost) Amount / Tender amount**, if bidder have not completed at least two contracts of same nature will provide performance security as under:
 - i. 5% for two contracts of same nature along with its completion successfully.
 - ii. 10% for new entrants contractor.
 - f. Bidder shall demonstrate **Cash or Cash Equivalents equal to 20% of contract value** and current contract commitments. In this regard bidder shall provide the bank statements of last three months
 - g. Bids will be evaluated by the Evaluation Committee in accordance with the tender conditions in bidding documents & PPRA Rules.
 - h. All safety instructions narrated in NEPRA Safety Code must be adopted in true letter and spirit
4. Eligible Bidders may obtain any information regarding Bidding from the Office of **Project Director (Construction) FESCO, Faisalabad on or before 26.12.2025 upto 04:30 PM**.
5. All bids must be accompanied by a Bid Security amounting to **2% on BOQ (Cost) amount / Tender Amount** each in favor of **Project Director Construction FESCO Faisalabad** issued from any scheduled bank of Pakistan and shall be valid 28 days beyond bid validity. The bid shall be valid for 120 Days.
6. The bids will be opened at the office of **Project Director (Construction) FESCO Faisalabad** in the presence of bidders / bidder's authorized representatives who choose to attend the tender.
7. Tender rates and amounts should be filled in figures as well as in words. Tender documents should be signed as per general directions given in the tender documents.

9. No rebate on tender rates will be acceptable.
10. All the procurement will be done according to PPRA Rules-2004 amendment up-to date.
11. Conditional Bid shall not be permitted and all the pages of tender will be marked as page No. and each page must be signed & stamped by the bidder.
12. The bids covering partial and incomplete work shall be rejected.

Note: -

- i. The bid validity must be as specified in the tender documents.
- ii. Tenders will be opened on PPRA EPADS on the date and time mentioned above.
- iii. A Bid Security/Guarantee as indicated on EPADS and bidding documents must accompany the bid; otherwise, the bid will be rejected.
- iv. Original Bid Security/Guarantee must be submitted in the office of the undersigned before the closing time for receiving tenders.
- v. Bidding documents, containing detailed specifications, terms & conditions, and other relevant information, are available on EPADS (www.eprocure.gov.pk). Bidders must register on EPADS and submit their electronic bids through EPADS on or before 29-12-2025 upto 12:15 PM. Bids will be opened at 01:15 PM on the same day at the office of Project Director (Construction) FESCO at Old Thermal Plant, Abdullahpur, Faisalabad.
