ELIGIBILITY

2. This Invitation for Bids is open to all Bidders meeting the following criteria:-

- a. Pakistan Engineering Council Certificate renewed for the **year 2025-26** with Category having Specialization Code as mentioned against above must be provided.
- b. **The bidder shall be in the active tax payer list (ATL), and will provide** income Tax Returns for last three years.
- c. The contractors are required to submit their registration for sales tax with Punjab Revenue Authority.
- d. The bidder must have completed at least two contracts of same nature along-with its successful completion certificate as main contractor **within Ten years**.
- e. The bidder should have an **Average Annual Turnover half times of the amount** mentioned against this work during last three years certified from audited financial statement.

- f. Bidder shall demonstrate **Cash or Cash Equivalents equal to 10% of contract value** and current contract commitments. In this regard bidder shall provide the bank statements of last one (01) year.
3. Eligible Bidders may obtain further information, inspect and acquire the Bidding Documents from the Office of **Superintending Engineer (Civil) FESCO, Faisalabad** up-to **17.12.2025**.
 - a. Bid must be submitted through E-PADS on **18.12.2025** up-to 11:30 AM
 - b. Bids will be opened through E-PADS on **18.12.2025** at 12:00 Noon
4. Tender documents can be obtained / downloaded from the E-PADS/PPRA Website (www.eprocure.gov.pk) and the same may be uploaded on E-PAD after completing the required documents.
5. All bids must be accompanied by a Bid Security amounting to **5% on BOQ amount** each in favor of **Executive Engineer (Civil) Civil Works Division-II FESCO Faisalabad** of any scheduled bank of Pakistan and shall be valid 28 days beyond bid validity. The bid shall be valid for **140 Days**.
6. The bids will be opened at the office of **Superintending Engineer (Civil) FESCO, Faisalabad** in the presence of bidders / bidder's authorized representatives who choose to attend the opening process.
7. The bidder must stamp & sign at each page of bidding documents and all enclosures.
