The **WAPDA Hospital Peshawar**, under the administrative control of Pakistan Water and Power Development Authority (WAPDA), intends to utilize funds from its own resources toward the expenditure of the Framework Agreement for Hospital Laundry Services, and intends to apply part of the proceeds toward payments under the Call-off Contracts to be concluded under this Framework Agreement.
2. The WAPDA Hospital Peshawar intends to prequalify suppliers for the subsequent Invitation to Bid(s) and to sign the Closed Framework Agreement(s) with the successful bidder(s) following the bidding process.
3. The objective of the intended Closed Framework Agreement(s) is to ensure the Laundry services for WAPDA Hospital Peshawar through subsequent Call-off Contracts. The purpose of this Prequalification Notice is to provide basic information enabling potential applicants to decide whether or not to participate in the prequalification process.
4. Only the prequalified applicants shall be entitled to participate in the subsequent bidding proceedings. It is expected that the Invitation to Bids will be published through EPADS for prequalified suppliers on 05 January 2026, and the Closed Framework Agreement(s) will be signed between WAPDA Hospital Peshawar and the successful bidder(s) on 30th January 2026 for a period of one (01) year, extendable based on performance and mutual consent.
5. The prequalification process is open to all national firms/suppliers fulfilling the eligibility and qualification criteria mentioned in the respective Prequalification Documents. Interested applicants may obtain further information from WAPDA Hospital Peshawar during office hours 09:00AM to 04:00 PM or through the EPADS portal (<https://eprocure.gov.pk>)
6. The Prequalification Documents are available online on the EPADS portal (<https://eprocure.gov.pk>) and may be accessed after signing up and submitting the required information. Applicants are advised to remain in contact with the portal for any clarifications, addenda, or amendments to the Prequalification Documents issued by the WAPDA Hospital Peshawar.
7. Applications for Prequalification shall be submitted electronically through the EPADS portal no later than 11:00 AM on 15 December 2025. Applications submitted by hand, email, or courier shall not be entertained.
8. The tender will be opened in the presence of participants or their authorized representatives (bearing authority letters) who attend O/O Procurement Cell of WAPDA Hospital Shami Road, Sakhi Chashma, WAPDA House, Peshawar
9. In case of holiday announced by the Govt. of Pakistan, or any other reasons whatsoever due to which this office remains closed on the above schedule tender opening date, the tender will be opened on next working day at the same time and place/venue.
10. WAPDA Hospital Peshawar reserves the right to reject the bids as per PPRA Rule-33 (1) 2004 (amended to date).
