6. **Method of Procurement - Single Stage Two Envelopes, under PPRA Rules 2004**

Separate sealed bids comprising of **Technical and Financial Proposals** in respective envelopes duly prepared in accordance with instructions contained in the bidding documents must reach Works Dte on **6 January 2026** at **1400 hours**. Technical proposals shall be opened on same day at **1430 hours** in presence of NUST Bid Opening Committee and bidders / representatives at Works Dte Conference room.
- b. Bid security must be attached with Financial Proposal.
- c. Financial proposals of technically qualified bidders shall be opened at Works Dte conference room for which date and time shall be intimated later.
