1. **Invitation to Tender.** The Central Ordnance Depot (COD) Karachi invites sealed bids from eligible and registered suppliers for the supply of stores as per the enclosed list (Anx 'A' & 'B'). Bidding shall be conducted in accordance with the Public Procurement Regulatory Authority (PPRA) Rules, 2004 (as amended).
2. **Tender Submission Requirements.** Bidders must submit the following documents in sealed separate envelopes (Technical and Financial Proposals separately):
 - a. Original bid, along with a duplicate copy
 - b. Photocopy of Registration Letter issued by COD
 - c. Attested copies of:
 - i. Sales Tax Registration Certificate
 - ii. National Tax Number (NTN) Certificate
 - iii. CNIC of Managing Director/Proprietor
 - iv. Attested Bank Statement for the last one year
 - v. Undertaking on Rs. 100 judicial paper attested by Oath Commissioner confirming:
 - vi. The firm is not blacklisted or under embargo by any Government organization
 - vii. The firm has not been involved in litigation or default
 - viii. The firm accepts all terms and conditions of this tender
 - ix. Photocopy of Registration letter issued by Central Ordnance Depot.
3. **Technical Specifications & Samples.** Technical drawings/specifications can be obtained from the Local Purchase Branch, COD Karachi. Offered stores must strictly conform to Army-approved specifications, drawings, and samples Only brand new and unused items will be accepted Items must be packed in standard packing (wooden box, carton, crate, etc.).
4. **Tender Schedule.**
 - a. Last Date & Time for Submission: 06 Jan 2026, up to 1030 hours
 - b. Date & Time of Opening: 06 Jan 2026, at 1100 hours
 - c. Submission Point: Local Purchase Branch, COD Karachi
5. **Pricing & Quotation Instructions.**
 - a. Prices/rates must be quoted clearly against each item. Items not being quoted must be marked as "**NOT QUOTED**"
 - b. Bidders must submit:
 - c. A hard copy (typed, not handwritten) signed and stamped on each page
 - d. A soft copy in Excel format via USB
 - e. No alteration of rows/columns or serial numbers is allowed in the quoted list
6. **Terms & Conditions**
 - a. The purchaser reserves the right to accept or reject any bid wholly or partially as per Rule 33 of PPRA Rules
 - b. Prices shall remain valid until 30 Jun 2026
 - c. All applicable government taxes must be included in the quoted rates
 - d. Items will be inspected/tested by authorized bodies (Board of Officers, QA Lab, or others)
 - e. During the warranty period, suppliers must replace/repair defective items within 7 days of notification.

- f. All supplies will be subject to tests and inspection (s) either by a Board of Officers constituted for the purpose or by IAS&C, Quality Control Lab or user acceptance. Any cost incurred on tests / inspection (s) and store (s) consumed in the same will be borne by suppliers(s).
 - g. In case no specifications & drawing exist for any item, Army will appoint Board of Officers to determine the acceptable standards.
 - h. Successful bidders will have to complete the supplies within stipulated period as specified in the purchase order(s), failing which appropriate penalty as decided by Commandant Central Ordnance Depot Karachi will be imposed along with, appropriate disciplinary action.
 - i. The decision of Commandant Central Ordnance depot Karachi shall be final authority in terms of acceptance or rejection of any offer.
