

2. The contractors are required to submit their application to Commander MES (Army)-II Quetta for issuance of tender documents alongwith their complete credentials. The application shall be scrutinized and the tender documents will only be issued to the firms who have sufficient experience in the relevant field and satisfy other special conditions required for the job and area. Tenders will only be issued to the securitized contractors. The tender must be received in the office of accepting officer by 31 Dec 2025 till 1100 hours and will be opened at 1200 hours on the same date.

Note: Contractors shall provide certificate that they are not involved in any type of litigation with Government Department in the court of Law and that no special report of Directorate of Inspection and Evaluation (E-in-C's Branch, GHQ, Rawalpindi).

3. All contractors will certify in writing that they are registered with Pakistan Engineering Council (PEC) and will submit a copy of their registration contractors not registered with PEC are ineligible to apply.

4. Firms / contractors who are enlisted with MES in categories 'D' may apply for work.

5. Firms / Contractors not borne on approved list of MES will furnish their applications alongwith statement of previous experience giving details of work executed during last two years and those in hand, on the proforma appended below:-
