INVITATION OF BIDS

Procurement of Design, Supply, and Implementation of a Modern, Resilient, and Scalable Data Center facility expansion for the DGIP (Headquarters), Islamabad.

The Directorate General, Immigration & Passports (DGIP), Ministry of Interior, Government of Pakistan, invites bids through the PPRA's e-Pak Acquisition & Disposal System (EPADS) from authorized service providers or principals' authorized dealers based in Pakistan for the design, supply, and implementation of an expansion Data Center facility. Detailed technical specification and requirements are provided Annexure-I of the bidding document.

Bidders must be registered with Federal Board of Revenue (FBR) /respective Revenue Boards for Income Tax and Sales Tax and must appear on Active Taxpayers List (ATL) for the both taxes.

Background:- This Invitation of Bids follows Tender Notice No.01/01/Data/Center/2025/LOG/PSDP/Retender published on the PPRA,DGIP website and in two national daily newspapers regarding the Data Center facility expansion for the DGIP (Headquarters), Islamabad for the above- mentioned purpose.

Bid Security:- All bids must be accompanied by a Bid Security amounting to Rs. 1,420,000/-. The original bid security must be submitted to DGIP (HQ), Islamabad before the bid submission deadline, failing which the bid shall be rejected. The Bid Security shall be in the form of a Bank Guarantee, Banker's Cheque, Pay Order or Bank Draft, issued by a scheduled bank in Pakistan, and must remain valid for thirty (30) days beyond the bid validity period.

Bidding Procedure:- The bidding shall be conducted in accordance with the Single Stage Two-Envelop as prescribed in the Public Procurement Rules 2004, and any other applicable regulations or guidelines issued by PPRA.

A pre-bid meeting will be held on **19 December, 2025 at 03:00PM at DGIP (HQ), Islamabad.**

Availability of Bidding Documents:- complete Bidding documents, including Terms and conditions, Scope of Work, Instruction to Bidders, Bid Evaluation Criteria, Bid Validity, submission requirement, and details specification Annexure-I, are available on EPADS at <https://eprocure.gov.pk/>.

Submission and Opening of Bids:- Bids must be submitted electronically through EPADS only. In accordance with instructions provided in the bidding document. The Original Bid security must be delivered to the address below on or before **03:00PM on December 31st, 2025.** Electronic bids will be opened the same day at **03:30 PM** through EPADS
