## **TERMS AND CONDITIONS**

1. **Bidding Procedure:**
  - Single Stage-Two Envelope Procedure as per PPRA Rule 36 (a).
2. **Eligibility Criteria:**

Bidders must:

  - Be Registered with FBR (Valid NTN & GST)
  - Provide an affidavit of non-blacklisting
  - Show proof of similar supplier to the government / semi-government entities
3. **Bid Submission:**
  - Submit bids through PPRA e-paid and to the Office of the **Director, Regional Meteorological Center (RMC)** Khyber Road Peshawar.
  - Mark Envelope as:  
“Repair & up-gradation to 10 KVA Hybrid Solar System for Seismic building at RMC Peshawar”
4. **Bid Security (Earnest Money):**
  - 2% bid security of the total quoted amount (inclusive of GST) must be submitted as a Pay order/ Bank draft in favor of Director, RMC Peshawar in Pakistani Currency.
  - Bid without Earnest Money will be rejected.
5. **Bid Validity:**
  - The bids shall remain valid for a period of three months (90 days) from the date of opening of the tender (Rule 28)
  - If required, the procuring agency may request an extension in the validity period, subject to the written consent of the bidder.
6. **Supply Schedule:**
  - The successful bidder shall deliver the items on quarterly basis as per the procuring agency requirements (Rule 15)
  - Quantities and delivery schedules will be communicated prior to start of each quarter.
  - The bidder must ensure timely delivery to avoid disruption in operations.
7. **Delivery Schedule:**
  - Items must be delivered within 15 days of issuance of the purchase order.
  - A 1% penalty per day will apply for delays beyond the specific time.
8. **Payment Terms:**
  - Payment will be made via Cheque after the inspection and satisfactory delivery by the Technical Committee.
9. **Taxes:**
  - Prices quoted must be inclusive of all applicable taxes.
  - Taxes will be deducted at source as per governments rule.
10. **Rejection of Bids:**
  - The procuring agency reserves the right to reject any or all bid as per PPRA Rule 33.
11. **Bid Opening:**
  - Bid will be publicly opened at the specified date and time in presence of bidders or their representatives.
