- Contractors who are not enlisted with MES will deposit 5% as earnest money and in any sch Bank of Pakistan in favour of AGE (A) SI&T Qta and the Treasury Receipt, Bank Receipt will be sent along with the application.
- Tender must be comprised on two envelopes, one contains priced tender and other priced BQs duly seal.
- If tender of contractor not enlisted with MES is accepted he shall be required to deposit Rs 40,000/- as security in the firm as demanded by accepting officer. Tenders shall be issued to contractors upto **05th Jan 2026** during office hours.
- Copies of the conditions of contracts, schedule, drawing and all other documents connected with the work can be examined / obtained from the office of undersigned.
- Tender must be quoted on MES Schedule of Rates 2021. Tenders must be reach before **05th Jan 2026 11:00** Hrs and will be opened at 1200 hrs on the same date.
