**HIRING OF LEGAL ADVISORS/ CONSULTANTS FOR REGIONAL TAX OFFICE  
QUETTA**

The FBR aims to strengthen its legal operations by hiring qualified Legal Advisors to assist its Directorates Law-IR /Commissioner-IR/Directors under the Inland Revenue Services. These advisors will support ensuring effective legal compliance, improved litigation outcomes and enhanced legal advisory services. The applications are invited from the advocates for appointments as individual consultants to assist the Office of the Chief Commissioner-IR, Quetta in handling legal matters of the department. The office requires two (2) Legal Advisors/Consultants for RTO, Quetta.

**Terms and Conditions**

- i. The quotations / tenders should only be submitted electronically online, on or before **26.12.2025 at 11:30 am** through e-Tender portal of PPRA web site which will be opened on the same day electronically at 11:30 am. The contractors will be able to see comparative statement online.
- ii. The interested candidates are requested to **submit their Bids/ proposals online through EPADS at <https://eprocure.gov.pk>, and Original Bids/ proposals must be submitted at Regional Tax Office, Spinny Road, Quetta before opening date i.e. on or before 11:30 Hours on 26.12.2025**. The tender will be opened publically on the same day at 11:30 Hours in the presence of Candidates representatives at Regional Tax Office, Quetta.
- iii. Bidding will be conducted under the National Bidding Procedure specified in the Public Procurement Rules, 2004 (PPRA-2004) as per Rule 36-(a), under single stage, and envelopes procedure.
- iv. Interview/call letters to eligible candidates shall be issued by the Selection Committee.
- v. Incomplete applications and applications received after due date shall not be entertained.
- vi. Original documents shall be produced at the time of interview.
- vii. The competent Authority has the right to increase/decrease the number of Panel Advocates or cancel the hiring process at any time.
- viii. The initial engagement shall be for a period of Six (06) months, extendable by the Chief Commissioner-IR based on performance and requirements.
- ix. Academic Qualification: LLB or equivalent qualification from a recognized university/affiliated institute.
- x. Professional Experience: At least 5 years of High Court (Post-Qualification), preferably in tax laws.
- xi. Applicant must be an Enrolled Advocate eligible to appear before the High Courts.

**How to Apply:**

Interested candidates are required to apply and send their applications along with curriculum vitae, copy of CNIC, High Court enrolment card, academic credentials, experience certificates and list of reported/un-reported judgments to the office of ADC (HQs) / Member Selection Committee for Hiring of Legal Advisors as Individual Consultants, Chief Commissioner's Regional Tax office, Spinny Road Quetta. Last date for submission of application is 26-12-2025.
