Instructions to Bidders: -

1. Bidding documents are available on PPRA E-Pads portal only. No hard issued.
2. Only firms / contractors registered with PPRA E-Pads as vendors are eligible through online E-PADS Tendering. The bidders shall complete and authenticate their complete E-bids (by uploading PDF File) and it must be submitted online on e-Procurement system (EPADS) website i.e. <https://eprocure.gov.pk>.
3. The prospective bidders are required to submit Bid security / Earnest Money (CDR) amounting to as above mentioned against work in favor of Cantt Executive Officer Cantonment Board Sargodha, Club Road Sargodha Cantt, CDR must be issued from any schedule bank against firms' account. Name of Firm should be clearly mentioned on instrument (Call Deposit / CDR). The prospective bidders shall upload scanned copy of Bid Security on E-PADS and original will be submitted Three (03) days before opening of Bids & pay order is not acceptable.

4. The prospective bidders shall upload scanned copy of certificate is required on Original Judicial Stamp Paper for tender worth of Rs. 1200/- their firm are not involved in any litigation.
5. The prospective bidders are also required to submit their Bids online through E-PADS at <http://eprocure.gov.pk> before opening date Original bids in accordance with the provisions of Rule 36 (a) of Public Procurement Rules 2004 and terms & condition defined in the bidding documents.
6. The mode of procurement will be single stage single envelop. Interested bidders are required to submit both Technical and Financial Proposal. Initially only the technical bids will be opened and will be evaluated in accordance with laid down evaluation criteria as well TORs as provided in the bidding documents. Financial bid shall only be opened only of the technically qualified bidder.
7. The Bids will be opened publicity on 29-12-2025 at 01:30 Pm in the presence of Bidders authorized Representatives who choose to attend the opening session to be held at the office of Cantonment Board Sargodha, located at Club Road Sargodha Cantt.
8. Bids not carrying the performance security shall be rejected. The performance security of the successful bidder shall be released after completion of the project.
9. Participants / firms must submit attested copies of relevant documents with original bid security / CDR's.
10. A pay order or call deposit amounting to Rs 20,000/- per lot issued by a bank in favor of under signed must be provided after awarding tender to the successful bidder for performance guarantee. Outdated or expired CDR will not be accepted.
11. Quoted rates shall be inclusive of all applicable govt. (federal / provincial taxes).
12. The successful bidder shall be bound to execute an agreement with the procuring agency and all terms & conditions including tender notice shall be binding on hi.
13. Bidder/contractor blacklisted by any government / semi government department or involved in litigation or found to be indulged in corrupt and fraudulent practices will be considered non-responsive by the procuring agency.
