- 1 Bidder may obtain Tender documents from [Http://eprocure.gov.pk](http://eprocure.gov.pk). Bidders must submit their technical proposal and financial proposal through E-Pak Acquisition & Disposal system (E-PADS). Bid must be accompanied by a scanned copy of Bid Security in the form of CDR/Pay order, of Rs.40000/- in the name of Divisional Accounts Officer, Pakistan Railways Peshawar. Whereas, bid security in original shall be submitted with the technical proposal in the office of Divisional Superintendent Pakistan Railways Peshawar (DTO Store Branch) along with other necessary documents as stated in the tender documents. Technical/financial proposal must be uploaded on E-PADS at 11:00 or before on 06-01-2026.
- 2 Only bids through E-PADS will be entertained and no other bid will be accepted except E-PADS.
- 3 Technical bids will be opened on the same date at 11:30 hours on 06-01-2026 in the presence of all bidders, whereas, financial bid will be opened after the evaluation of Technical bids.
- 4 The Railway administration may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The Railway administration shall upon request communicate to any supplier or contractor who submitted a bid or proposal the ground for its rejection of all bids or proposals but in not required to justify the grounds.


