The notification using the form included in Section 9 (Contract Forms) shall include the following information:</i></p> <ul style="list-style-type: none">a) <i>the name of each Bidder who submitted a Bid;</i>b) <i>the bid prices as read out at bid opening;</i>c) <i>the name and evaluated prices of each Bid that was evaluated;</i>d) <i>the name of Bidders whose bids were rejected and the reasons for their rejection;</i>e) <i>the name of the winning Bidder, and the price it offered, as well as the duration and summary scope of the contract awarded; and</i>f) <i>a statement of the reason(s) the bid of the unsuccessful Bidder to whom the notification is addressed was unsuccessful, unless the price information under (d) of this paragraph already reveals the reason.</i>

All other terms and conditions of the Bidding Documents for the Package ADB-EPC-003-LESCO-2025 shall remain the same.
