
Subject: Local Purchase of Ordnance Stores FY 2025-26

1. Store mentioned at Annexure 'A' are urgently required. Please forward your quotation through bearer / by post, so as to reach Commandant Central Ordnance Depot Lahore Cantonment latest by **06 Jan 2026 at 1100 AM** and will be opened on **06 Jan 2026 at 1130 AM** in the presence of Depot Board of Officers representatives of the firms, if desired.
2. Accounting Unit and Nomenclature of item will not be amended. Over writing of rates will not be accepted. Your firm will be held responsible for any negative report regarding quality rates. In this connection render a certificate from your side which depicts complete satisfaction regarding quality/rates.
3. Firm's stamp, NTN, CNIC, Letter number of the firm and IT letter number must be endorsed on all quotations. Incomplete quotations will not be accepted.
4. Rates must be given as per DGP (A) specification which may be checked before quoting.
5. **5% of bid price (refundable) will be submitted alongwith bid / quotation in shape of bank draft / pay order in favor of Commandant Central Ordnance Depot Lahore otherwise quotation will be rejected.**
6. **The rates quoted should be as per accounting unit, confirm and final including all taxes/duties and valid upto 30 Jun 2026.** No change in quoted rates will be accepted later on subject to any cause i.e. fluctuation in value of foreign currency or all types of government duties/ taxes.

7. The stores offered must confirm to the standard specification and will be on firm's standard **One Year** warranty / user acceptance.
8. **Three lowest bidders will deposit one advance sample of quoted item for inspection in COD Lhr within seven days when asked by this depot. On non provision of advance sample whole IT of the firm will be cancelled.**
9. **Store (s) delivered must be packed in standard packing i.e. wooden box, carton, cardboard box, crate etc, without packing store will not be accepted.**
10. Inspection of complete stores, if ordered will be carried out by competent inspection authority. Charges for inspection store / test if any from any Government / non Government Organization will be paid by firm whenever asked by Depot.
11. Pre-qualification of firms:-
- a. Only those firms can participate who are already registered with COD Lahore Cantt/DGP (Army)/ DGDP or willing to get themselves registered with COD Lahore Cantt.

- b. Original manufacturers and suppliers, original stockiest in trade (In case of dealers, authority letter of original manufactures be attached).

Commandant Central Ordnance Depot Lahore reserves the right to reject any inquiry / quoted rates (considered contrary to the spirit of tender competition / incomplete/ low quality samples or samples not of required Army specification), change delivery target and increase/ decrease the quantity at any stage.
