Complete bidding documents, duly signed and stamped with filled BOQ on prescribed format is to be uploaded on EPADS. Conditional tenders will not be accepted.

4. A bank draft or pay order for Rs. 55,000/- in favor of "Pakistan Airports Authority" as earnest money must accompany the tender documents. Tenders without earnest money will not be considered.

The original bid security and one sealed hard copy of bidding documents uploaded on EPADS must be submitted to the office of the Divisional Engineer ES Civil Landside IIAP, Islamabad before the bid opening date and time. Bids without the receipt of the original Bid Security in hard form prior to the bid opening time and date will not be entertained.
6. Pakistan Airports Authority reserves the right to accept or reject any or all bids with valid reasons, which will be communicated to bidders upon request.
7. The bidder must complete and sign the "Letter of Offer for Execution of Works" included in the bidding document.

9. Bidders must upload the following documents along with bidding document on EPADS and the same must be enclosed with hard copy of bidding documents:
- An affidavit of details of pending litigation (if any) / blacklisting on non-judicial stamp paper with a minimum value of Rs. 200/-. If the firm is involved in any litigation, it must be disclosed in the affidavit.
 - For Private Limited firms, a duly attested Power of Attorney on non-judicial stamp paper (minimum Rs. 500/-) along with the Certificate of Incorporation issued by SECP/Registrar of Firms must be provided, whereas Sole Proprietors are required to submit a duly attested Affidavit of Proprietorship on non-judicial stamp paper (minimum Rs. 200/-).
 - Copy of valid income tax certificate /active taxpayer status and Professional Tax Certificate of current year.
 - CNIC copy of the owner & representative participating in tender.
 - Proof of payment of tender fee Rs. 2,000/- (non-refundable) in favor of PAA, deposited in PAA Collection Account No. 24807000037803, HBL IIAP Islamabad Branch.
