



INVITATION TO e-BIDS

Superintending Engineer / Project Director, Chashma Right Bank Canal Project, WAPDA, Dera Ismail Khan, invites electronic bids from contractors registered with Income Tax and Sales Tax Department as well as licensed by the Pakistan Engineering Council (PEC) in the following categories for the works mentioned below:

4. The electronic bids, must be submitted by using E-PADS on or before **09.01.2026** at **1100 HRS**. Manual bids, shall not be accepted. Electronic Bids will be opened on the same day at **1130 hours**. Single Stage one envelope procedure shall be followed for this procurement.

5. In addition to the bids to be uploaded on E-PADS, 02 Nos. hard copies of the bids should reach the O/o Superintending Engineer/PD CRBC (O&M) Project, Gomal Zam Dam Colony, D.I.Khan by 09.01.2026, 1100 HRS. In case of any discrepancy, the bid uploaded on E-PADS shall prevail.

6. Each bidder shall furnish a Bid Security mentioned in para-1, in the form of CDR or Bank Guarantee in favor of Superintending Engineer/PD, CRBC (O&M) Project, D.I.Khan.
