3. Following mandatory documents to be submitted with the proposal as per manners described in the Instructions to Bidders:
- Original Bid Security in favor of **Pakistan Airports Authority** shall reach office of the undersigned prior to bid submission time as per instruction to Bidders. Bids received without original security shall not be entertained. A Scanned copy shall be uploaded on EPADS.
 - Certificate of incorporation / Memorandum & Article of Association or Partnership Deed / Sole Proprietorship on stamp paper Rs. 200 etc. (as applicable) (*Attested by Notary Public / Oath Commissioner*).
 - Active Taxpayer Status (ATL), NTN Certificate.
 - Professional Tax Certificates issued by Excise & Taxation Deptt. Khyber Pakhtunkhwa or undertaking on non-judicial stamp paper (*Attested by Notary Public / Oath Commissioner*)
 - Valid Certification/ License by the Pakistan Engineering Council (PEC) i.e. C-5 (or above) with sufficient experience of runway seal coating works. The bidder shall provide documentary evidence i.e work order, completion certificate for the work executed on runways during the last five years.
 - Affidavit on non-judicial stamp paper Rs. 100 to the effect that the firm has not been blacklisted by any Government, Semi Government and Autonomous Body (*Attested by Notary Public / Oath Commissioner*).
 - Details of any arbitration / litigation of similar proceeding against any Govt. / Autonomous / Private body showing extent and results on non-judicial stamp paper Rs. 100 (*Attested by Notary Public / Oath Commissioner*).
 - Power of Attorney on stamp paper (if applicable)
 - Bidding Documents with each page to be signed and stamped by Authorized Representative of the Bidder.
