

- 2) The items offered for sale & vehicle can be inspected from 10:00 AM to 03:00 PM (Monday to Thursday) at PPMI Complex, Sector H – 8/1, Islamabad.
- 3) Bidders are required to submit **sealed bids** along with copy of valid CNIC before or on 14.01.2026 till 11:00 AM. Bids received after closing hours will not be entertained.
- 4) Bids will be considered valid only on receipt of refundable security money in the form of Pay Order in favour of the company, as indicated against items/ lot along with reserve price.
- 5) Bids without security money will not be entertained on any ground whatsoever.
- 6) Bids will be opened on 14.01.2026 at 01:30 PM in the Committee Room of the Ministry of Planning, Development and Special Initiatives Islamabad, in presence of bidders or their authorized representatives.
- 7) Rates quoted by bidders will be considered exclusive of government taxes. Successful bidder will be liable to pay all applicable taxes in addition to the bid amount, as per law.
- 8) Successful bidder will have to deposit One Fourth (1/4) of the total bid amount through PO within twenty four (24) hours i.e. by 15.01.2026 at 01:30 PM and the remaining Three Fourth (3/4) within seven days of the bid date i.e. by 22.01.2026. 


