4. The electronic bids, must be submitted by using EPADS on or before the date and time mentioned against each. Manual bids, shall not be accepted. Electronic bids will be opened on the same day at the time mentioned against each in the office of the Resident Engineer, Power Station Mangla.
5. Prospective Bidder may seek clarification (if required) on bidding documents prior to three days closing / deadline of respective bid.
6. Each bidder shall furnish the bid security for an amount as mentioned above, in the form of CDR in the favour of **Resident Engineer**, Power Station Mangla. Bid security in original must reach in the office of RE HPS Mangla before bid closing time.
7. The procuring agency may reject all bids at any time prior to the acceptance of a bid as per PPRA Rule-33.
