





2. Source of Funds		Source of funds is referred in Clause-2 of Invitation for Bids.
3. Eligible Bidders		<p>A Bidder may be natural person, company or firm or public or semi-public agency of Pakistan or any foreign country, or any combination of them with a formal existing agreement (on Judicial Papers) in the form of a joint venture, consortium, or association. In the case of a joint venture, consortium, or association, all members shall be jointly and severally liable for the execution of the Contract in accordance with the terms and conditions of the Contract. The joint venture, consortium, or association shall nominate a Lead Member as nominated in the BDS, who shall have the authority to conduct all business for and on behalf of any and all the member\s of the joint venture, consortium, or association during the Bidding process, and in case of award of contract, during the execution of contract.</p> <p><i>(The limit on the number of members of JV or Consortium or Association may be prescribed in BDS, in accordance with the guidelines issued by the PPRa).</i></p>

## Technical Specifications

### Notes for Preparing the Technical Specifications

A set of **precise and clear specifications** is a prerequisite for bidders to respond realistically and competitively to the requirements of the **Procuring agency** without qualifying their bids. The **specifications** must be drafted to permit the **widest possible competition** and, at the same time, present a **clear statement** of the required standards of **workmanship, materials, and performance** of the goods and services to be procured. Only if this is done will the objectives of **economy, efficiency, and fairness** in procurement be realized, **responsiveness of bids** be ensured, and the subsequent task of **bid evaluation** facilitated.

The specifications should require that all **goods and materials** to be incorporated in the goods be **new, unused, and of the most recent or current models**, and that they incorporate all **recent improvements** in design and materials unless provided for otherwise in the contract.

Samples of specifications from **previous similar procurements** in the same country are useful in this respect. The use of **metric units** is encouraged. Depending on the **complexity** of the goods and the **repetitiveness** of the type of procurement, it may be advantageous to **standardize the General Technical Specifications** and incorporate them in a **separate subsection**. The **General Technical Specifications** should cover all classes of **workmanship, materials, and equipment** commonly involved in manufacturing similar goods, although not necessarily to be used in a particular procurement. **Deletions or addenda** should then adapt the **General Technical Specifications** to the particular procurement.

Care must be taken in drafting specifications to ensure that they are **not restrictive**. In the specification of standards for **equipment, materials, and workmanship**, recognized **international standards** should be used as much as possible. Where other particular standards are used, whether **national standards** of the Procuring Agency's country or other standards, the specifications should state that equipment, materials, and workmanship that meet **other authoritative standards**, and which ensure at least a **substantially equal quality** than the standards mentioned, will also be acceptable. The following clause may be inserted in the **Special Conditions of Contract** or the **Technical Specifications**.


