The Islamic Republic of Pakistan has received financing from the Asian Development Bank (ADB) toward the cost of Power Transmission Strengthening Project (PTSP), and it intends to apply part of the proceeds of this financing to payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **National Grid Company of Pakistan Limited** ("NGC or the Purchaser") invites sealed bids from eligible Bidders for the "Procurement of 220kV Substation Equipment for 220kV Nowshera & 220kV Jamrud Substations". The material shall be procured in following **Two (02) lots**:

3. Open competitive bidding will be conducted in accordance with ADB's Single-Stage: One-Envelope procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualification should participate in this bidding:

## Technical Experience:

The Bidder or its proposed Manufacturer must have at least 05 years design/ manufacturing experience of similar Goods of the respective Lot having similar or higher rating and capacity.

The Bidder or its proposed Manufacturer shall have manufactured and supplied similar Goods of similar or higher rating and capacity in the quantities at least equal to the 100% quantities during the last ten (10) years in a single or multiple contracts. The Goods supplied by the bidder should have been in satisfactory operation for a continuous period of at least three years on the date of bid opening.

The Bidder or manufacturer shall demonstrate that it can supply the type, size, and quantity of the goods as required by Purchaser in accordance with the Delivery and Completion Schedule in Section 6 (Schedule of Supply) of Bidding document.

In case of JV, all partners combined should fulfill this requirement (draft JV agreement should be provided with the bid). The bidders, who are not manufacturers themselves, shall furnish an authorization from the concerned manufacturer to submit a bid for supply of their Goods to NGC in Pakistan against this bid.
