TERMS AND CONDITIONS

1. Tender shall be sent under sealed cover which should reach to the undersigned by **22.01.2026 at 2.00 P.m.** The tender will be **opened on the same day at 2.30 P.m.** in the presence of the tenderers or their authorized representatives who may like to attend. The bidding firms are required to enclose photo copy of PCP receipt regarding purchase of tender documents alongwith their sealed offers/bids.
2. The tender must be accompanied with Call Deposit/Pay Order/Demand Draft of Rs.500,000/- (Rupees five lac only) as earnest/security money in favor of the Printing Corporation of Pakistan (Pvt) Limited, Islamabad which shall be refunded on successful completion of the job.
3. The offer should be valid for 90 days from the date of opening of tender.
4. The rates may be given on the basis of “AS IS WHERE IS” for Mixed Waste Paper and Shaving (per Kg) separately for each item exclusive of taxes.
5. The successful Contractor shall be liable to pay all taxes as announced by the Government of Pakistan from time to time in addition to the sales price before lifting the material (waste) and get separate receipt/certificate from PCP for deposit of tax for his own record.
6. The payment of Mixed Waste Paper and Shaving duly weighted, including taxes shall be made in advance before lifting the same through cash payment.
7. Conditional, incomplete, overwritten and ambiguous tender shall not be accepted.
8. In case of default on the part of the successful bidder/contractor in carrying out of terms and conditions of this tender after its execution or using delaying tactics causing loss to PCP or any violation, in whole or part thereof, willfully and intentionally or subletting of contract, the security deposit shall be liable to be forfeiture in favour of PCP.
9. The Corporation reserves the rights to reject all or any tender in accordance with PPRA Rules 41.

10. The Corporation itself reserves the right to award the contract to more than one firm/party for any item. However, preference shall be given to the highest bidder.
11. The Contractor shall lift the available quantity of mixed waste paper and shaving within 30 days after issuance of written notice to do so whenever so required by the Management of PCP.
12. In case of failure to lift all the mixed waste paper & shaving within 30 days, the penalty @ 0.5 percent per day of the value of weighted waste already lifted by the contractor will be imposed on the firm/party which will be deducted from the security money of the firm/party.
13. The Security bid of the successful bidder will be retained while in the case of others, it will be refunded to them.
14. In case of any dispute in interpretation of the terms and conditions of this tender the Managing Director, PCP shall be the sole arbitrator and his/her decision shall be the final and binding upon all concerned.
