4. Prequalification documents can be obtained from GE (N) Maint Sector E-8 Islamabad.

5. Contractors NOT BORNE on MES approved list of contractors or THOSE SUSPENDED from the approved list of MES contractors due to non-depositing enhanced amount of standing security will deposit earnest money equal to 2% of the estimated cost of bid in the form of FDR, Deposit at Call, etc, duly pledged in the name of GE (Navy) Maint Islamabad. This amount is refundable, if the contractors are not pre-qualified or they do not secure the contract

6. Firms / Contractors not borne on the approved list of MES contractor will furnish with their application; proof of their being on the appropriate list of the Department concerned, a statement of financial standing with necessary bank certificate, details of staff employed, tools & plants / machinery and type of work executed in the last two years and in hand on the Proforma appended below, duly attested by Class-1 Gazetted Officer.

7. The applications will be scrutinized and tenders will be issued to the prequalified firm/contractors.

8. Accepting Officer may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. Accepting Officer shall upon request communicate to any contractor who submitted a bid or proposal, the ground for its rejection of all bids or proposals, but is not required to justify those grounds.

9. Any assistance and details i.e. specifications, drawings and un-priced abstract of the bills of quantities of works may be collected from GE (N) Maint Islamabad free of charge during working hours. (Tele No.051-20063403)
