The Karachi Shipyard and Engineering Works Limited (KS&EW) invites sealed bids on Single Stage Two Envelope procedure for project "Providing Services for Drilling of Bore Hole near Customer Rest Rooms - KS&EW" from eligible national constructors/ firms having valid registration with Pakistan Engineering Council (PEC) in category C-4 or above.
