3. Only bids through EPAD will be entertained and no other bid will be accepted except EPAD, bids will be opened on same date and venue at 11:30 hours in the office of Divisional Accounts Officer, Pakistan Railways, Sukkur, in the presence of the representatives of the firms who want to witness.

4. Duly filled Tender, Technical & Financial proposals in separate envelopes will be processed upto 11:00 hrs, and supported by bid money with technical proposal. Bid Security in the form of CDR/Pay order of schedule bank in favor of Divisional Accounts Officer Pakistan Railways Sukkur. However, financial proposals of qualified firms shall be opened for which date and time shall be communicated to technically qualified bidders accordingly.
