1. Introduction and Invitation

The **Pakistan Engineering Council (PEC)** hereinafter referred to as the Procuring Agency, intends to pre-qualify reputable and experienced manufacturers, principles, authorized distributors, or suppliers for the provision of IT equipment and related services in compliance with **PPRA Rules**.

Only those firms that meet the pre-qualification criteria set forth in this document shall be eligible to participate in the subsequent bidding process, which may lead to the signing of a Framework Agreement which will remain valid for one year, which may be extended upto further two years with mutual consent as per PPRA rules.

2. Scope of Goods and Services

The pre-qualification is for the supply, delivery, installation, configuration, and warranty support of various IT equipment/services. The pre-qualified bidder may bid for one or more categories as mentioned in table 1.1. The range of goods and services encompasses, but is not limited to, the following:

3. Eligibility Criteria

To be eligible for pre-qualification, applicants must provide documentary proof of fulfilling the following mandatory requirements. Failure to meet any of these shall result in disqualification.

- i. **Legal Status:** The Applicant must be registered/incorporated as a company or firm with SECP or firm of registrar having minimum 03 years registration status.
- ii. **Tax Compliance:**
 - o Must be an **Active Taxpayer (ATL)** on the list of the Federal Board of Revenue (FBR).

- iii. **Business Experience:** Minimum of 03 years of experience in the business of supply and installation of similar IT equipment to Government/ Semi Government /Corporate organizations.
- iv. **OEM/Principal Authorization:** The Applicant must be an **Authorized Dealer/Distributor/Partner** for the Original Equipment Manufacturers (OEMs) or Principal for the specific equipment or Software they intend to supply (e.g., Dell, HP, Lenovo, Canon, Oracle, SAP, Zoom etc.). OEM/ Principal authorization will only be applicable on proprietary software/hardware/products/services.
- v. **Non-Blacklisting Affidavit:** An affidavit (on non-judicial stamp paper of value not less than Rs. 100/-) confirming that the firm has never been blacklisted, debarred, or declared ineligible by any Government, Semi-Government, Autonomous Body, or Procuring Agency in Pakistan.

4. Evaluation Criteria

The pre-qualification applications will be evaluated based on the following criteria and scoring system. Only applicants achieving the minimum qualifying score for each criteria and overall total minimum score shall be considered as pre-qualified.

- Submission:** The applications must be submitted in a sealed envelope clearly marked "**Application for Pre-Qualification for the Supply of IT Equipment / Services with category name**" and delivered to the address below before the submission deadline.
- Right to Accept/Reject:** The Procuring Agency reserves the right to accept or reject any or all applications and to cancel the pre-qualification process at any time prior to the acceptance of a proposal, in accordance with **PPRA Rules**.
- Procurement Method:** Procurement from pre-qualified firms will be done through subsequent Invitation to Bids (ITBs) or Request for Quotations (RFQs) under the appropriate method specified in PPRA Rules.

4. **False Information:** Submission of false or misleading information shall lead to the automatic rejection and blacklisting of the applicant.
