The Prescribed Tender Fees amounting to <b>Rs. 3,000/- (Non Refundable)</b> and the Bid Security amounting to <b>Rs. 25,000/- fixed (refundable)</b> in Shape of Pay Orders, in favor of Chief Account Officer, KPT, alongwith an original hard copy of the Bids shall also submit in a sealed envelope at the time of Opening of Tenders.

Copy of Online Tax verification.</li><li>d. Copy of SRB Certificate.</li><li>e. Affidavit, that the firm is not defaulter in Income tax department nor blacklisted by any Organization on an E-stamp Paper.</li><li>f. a. In case of companies and firms, last 03 years Audited Financial Statements are to be provided showing minimum average turnover of Rs. 1.0 (M). b. In case of individuals / sole proprietors, last three years tax returns filed with FBR are to be provided showing minimum turnover of Rs. 1.0 Million on average.</li></ol>
