Contractor not born on MES approved list of contractor or THOSE SUSPENDED from the approved list of MES contractors due to non-depositing enhanced amount of standing security will deposit earnest money equal to 2% of the estimated cost of bid in the form of DSC. CDR etc, duly pledged in the name of GE (A) Kmr. This amount is refundable, if the contractors are not pre-qualified or they do not secure the contract.

8. Tender will be received on **12 Jan 2026** at 1130hrs and will be opened on **28 Jan 2026** at 1200 hrs.
