1. Bids may be submitted as per conditions set out in Auction/Tender documents downloadable from the website www.paa.gov.pk or obtainable free of cost from Logistics section CATI Hyderabad on **any working day between 0900 Hrs. to 1700 Hrs.**
2. **All Bids will be opened publicly in presence of the bidders on 21-01-2026 1100 at office of OIC Logistics CATI Hyderabad in presence of auction committee.** Bids must be dropped into the Tender Box placed at under mentioned office by or before due date i.e. **21-01-2026 1030 hrs.**
3. All interested parties may visit the site i.e Auditorium, Civil Aviation Training Institute (CATI), near Hyderabad Airport, Kohsar Hyderabad along with their original and copy of CNIC for on-site inspection and assessment on 19th - 20th January from 1000hrs to 1500hrs.
4. The highest bidder shall be required to deposit 25% of accepted bid amount on bid opening date while remaining 75% along with the admissible Govt. Taxes plus Rs 1/4th of bid amount as security deposit (refundable) will be deposited within (07) seven days from the date of bid acceptance letter failure to do so shall lead to forfeiture of 25% of bid amount deposited by the bidder without any compensation and next highest bidder shall be awarded the acceptance letter on prescribed terms and conditions.
5. The successful bidder shall not be allowed to sell the auctioned stores before he collects it from the site.
6. Acceptance letter shall be issued to the successful bidder after realization of balance bid amount within specified period.
7. Sale shall be made to the bidder offering the highest price subject to approval of competent authority and on receipt of complete payment.
8. The successful bidder shall be bound to dismantle/removal of auditorium chairs, lift and clear the site as per satisfaction of Auction Committee within seven (07) days from the date of issuance of letter of acceptance.

Any equipment / machinery left by the successful bidder after the completion of task at PAA property will be considered as the property of PAA.
